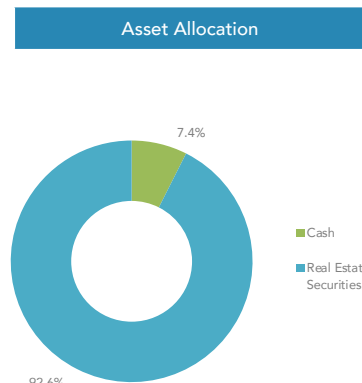
## MONTHLY COMMENTARY

Locally, the SA Listed Property Index (SAPY) recorded a total return of 1.92% for the month of November, with the historic yield of the SAPY ending the month at 6.68%. The yield-to-maturity (YTM) on the South African 10 yr government bond (R186) weakened by 25bps, ending the month at 9.34% (9.09% - 31 October 2017). Globally, the FTSE EPRA/NAREI Developed Rental Index recorded a net total USD return of 3.12% in November. The best performing listed real estate market was Hong Kong, which recorded a total USD return of 6.84%. The U.K. recorded the lowest total USD return for November of 2.06%.

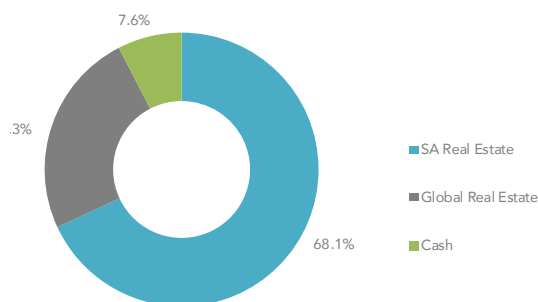
The Fund delivered 19.36% gross of fees total return for the 12 months ended 30 November 2017 relative to the fund's benchmark return of 9.26% total return. The fund's offshore allocation is approximately 57% on a see-through basis. The current forward yield of the SAPY is 7.24%. Earnings season came to a close in the month of November. Given the flat to negative earnings growth guidance provided by some management teams, many of the SA-centric companies are trading at attractive forward yields and significant discounts to NAV's. We continue to encourage management teams with capacity on their balance sheet to buy back shares in the companies they manage rather than pursue alternative investment strategies. Growth prospects for global real estate stocks, as a whole, remains relatively robust.
