# **MONTHLY COMMENTARY**

The SA Listed Property Index (SAPY) and the All Property Index (ALPI) recorded total returns of -1.29% and -4.60% respectively for the month of November, with the historic yield of the SAP ending the month at 9.33%. The yield-to-maturity (YTM) on the Long-Term South African government bond (RLRS) re-rated by 41 bps, ending the month at 9.22% (9.63% - 31 October 2018). SA bonds and SA cash recorded positive returns of 3.87% and 0.58% respectively. This trend is consistent with both year-to-date (YTD) and rolling 12-month performance. On a YTD basis SA Bonds were the outperformers with returns of 7.05%, followed by SA Cash (6.65%), SA Equities (-12.26%) and SA Property (-24.46%). SA Listed Property (SAPY) continues to underperform other asset classes on a rolling 12-month period.

During the month, earnings season continued unabated with a common narrative that the tough domestic conditions are expected to result in lower income growth over the short to medium term. The general theme was expected as it echoed similar sentiments delivered by management teams over the last few months. On the 28th of November Viceroy released a report on NEPI Rockcastle (NRP) where they alleged that NRP has intentionally mislead investors through an overstatement of net profit amongst other allegations. NRP responded by releasing a comprehensive rebuttal, hosted a global conference call with investors and subsequently had its credit rating confirmed by both 5&P and Fitch. On the initial release NRP's share price fell sharply as investors assessed the merits of the allegations. Following NRP's statements the share recovered somethat but ended the month below its pre-report level. Income yields have adjusted upwards in order to compensate investors for both higher perceived risk in the sector and downward revision to growth forecasts. On average, SA centric companies are trading at forward yields above the long-term South African Government Bond proxy (RLRS). Similarly, dual listed offshore companies are trading at attractive forward yields relative to their respective long-term government bond yields. We expect the sector to achieve inflationary growth in distribution per share over the long term. tor to achieve inflationary growth in distribution per share over the long term.


# **FUNDS SECTORAL ALLOCATIONS** AS AT 30 NOVEMBER 2018
