### MONTHLY COMMENTARY

The SA Listed Property Index (SAPY) and the All Property Index (ALPI) recorded total returns of -5.70% and -4.75% respectively for the month of February, with the historic yield of the SAPY ending the month at 9.23%. The yield-to-maturity (YTM) on the Long-Term South African government bond (RLRS) de-rated by 13bps to end the month at 9.06% (8.93% - 31 January 2019). SA Listed Property recorded the lowest total return (-5.70%) for the month of February, with the highest for the month coming from SA Equities (3.41%) followed by SA Cash (0.55%) and SA Bonds (-0.44%). SA Listed Property (SAPY) continues to underperform other asset classes on a rolling 12-month period (-5.20%), with SA Cash outperforming with returns of (7.26%), followed by SA Bonds (4.21%) and SA Equities (-0.90%).

Domestic property fundamentals have remained weak as lacklustre economic growth and high unemployment continued to place pressure on domestic demand and supply conditions. February was the beginning of results season and a common theme throughout the updates was the continuation of this downward trend. Due to poor fundamentals, vacancy levels across the sectors are increasingly difficult to maintain with large incentives being provided to tenants through significant negative rental reversions, rent free periods and/or additional capital expenditure to retain and attract new tenants. This combined with unsustainable/non-recurring earnings distributed in prior periods, lower expected M&A growth and increasing leverage have continued to result in downward revisions to growth forecasts. Over the long term, based on the sector de-rate during the month and continued underperformance relative to other asset classes, we currently view SA Property as attractively priced. On average, SA-centric companies are trading at forward yields (10.0%) above the Long-Term South African Government Bond (9.06%). We expect the sector's growth in distribution per share over the medium term to be inflationary.

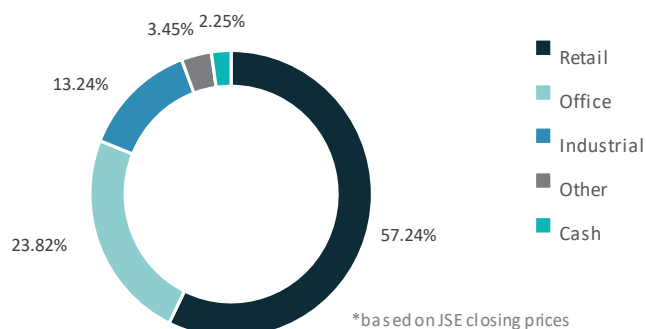

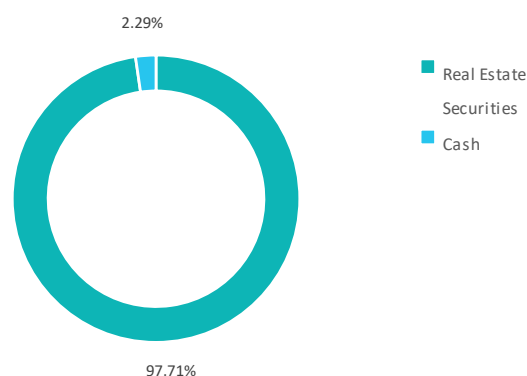
