MONTHLY COMMENTARY

The SA Listed Property Index (SAPY) and the All Property Index (ALPI) recorded total returns of 3.17% and 2.03% respectively for the month of April, with the historic yield of the SAPY ending the month at 9.13%. The yield-to-maturity (YTM) on the Long-Term South African government bond (RLRS) re-rated by 2bps to end the month at 8.97% (8.99% - 31 March 2019). SA Equities generating the highest return (4.23%) for the month of April, with SA Bonds delivering (0.80%) and SA Cash (0.63%). SA Listed Property (SAPY) continues to underperform other asset classes on a rolling 12-month period (-9.63%), with SA Cash outperforming with returns of (7.27%), followed by SA Bonds (4.97%) and SA Equites (3.90%). The Fund delivered a gross of fees return of -7.58% for the rolling 12 months ended 30 April 2019, ahead of the benchmark return of -11.05%.

The month of May will be a busy month with many companies with February/March interim or year ends expected to release results during the period. We continue to expect negative news out of the office sector and expect to see continued pressure on retail trading densities as consumer spending continues to be under pressure. The current forward yield of the SAPY and ALPI are 9.45% and 8.97% respectively. On average, SA-centric companies are trading at forward yields of c.10.0%, with the yield on the Long-Term South African Government Bond at 8.97%. The yield spread between the SAPY and the 10yr government bond proxy remains positive and above the historical average, with the relatively high forward yield of the SAPY compensating investors for the muted growth expectations in dividends over the short term. We expect the sector's growth in dividends per share over the medium term to be inflationary.

Over the long term, we expect the SA listed sector to deliver 13 - 15% total return in ZAR, largely driven by the income yield and capital return will be driven by the income growth.


FUNDS SECTORAL ALLOCATIONSAS AT 30 APRIL 2019
