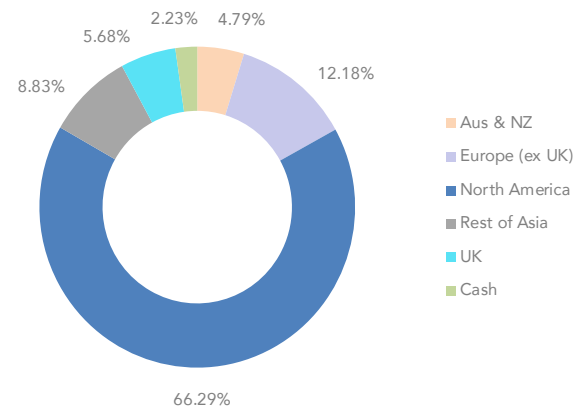

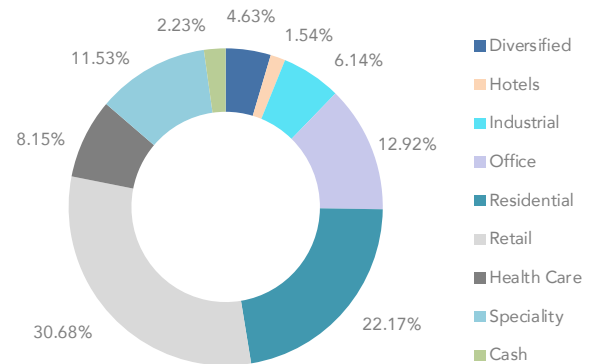

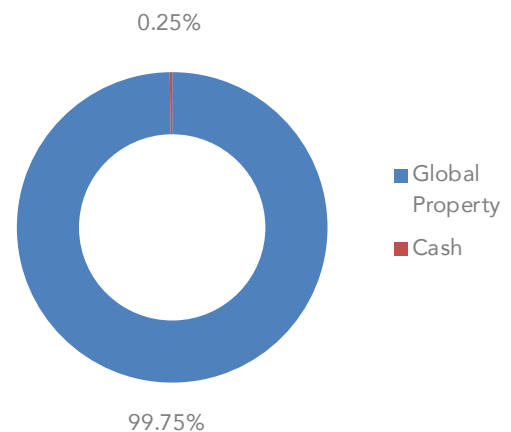
Underlying Funds Geographic Allocation as at 31 July 2017
