MONTHLY COMMENTARY AS AT 31 DECEMBER 2017

The FTSE EPRA/NAREIT Developed Rental Index recorded a net total USD return of 1.24% in December. The best performing listed real estate market was the UK, which recorded a total USD return of 8.22%. Japan recorded the lowest total USD return for December of -0.43%.

As we look back over 2017, the year will be remembered for the flurry of merger and acquisition activity that closed out the year and the widespread structural changes affecting the retail world.

One of the most significant events of the year in the mall sector was Brookfield's bid to take GGP Inc. (GGP) private. GGP has not been immune to the rhetoric that all physical retail is doomed and saw retail names coming under increasing pressure for much of the year. So, it was against this backdrop that Brookfield's bid for the remaining shares of GGP brought about a resurgence amongst the retail names, seeing a wave of high profile acquisition activity in the mall space around the world.

Next was the UK listed shopping centre owner, Hammerson, who made an opportunistic bid for its rival, Intu Properties. Intu Properties lost a third of its share value in 2017 alone and traded at a 50% discount to Net Asset Value before the deal was announced. Hammerson's management team who will have their work cut out for them amongst an environment of falling retail sales, rising food prices, weak pay growth and economic uncertainty which has dented consumer confidence.

The darling of 2017 was without a doubt the industrial sector, supported by higher manufacturing demand (US manufacturing sentiment in September was at its highest level since 2004) and structural changes relating to e-commerce. Across the world, customer demand for ever faster delivery is reshaping last mile delivery. Well-located logistics facilities on the fringes of urban areas are expected to continue to see robust rental growth going forward.

The single-family housing sector has received much attention with the eagerly anticipated listing of the Blackstone-backed Invitation Homes. The institutionalisation of the single-family rental industry was born out of the Global Financial Crisis where private equity players were able to acquire foreclosed homes at significant discounts. While individual investors have always owned homes for rental, the scale of these professional players is unprecedented. Although still in its infancy as an asset class the companies have had to quickly learn how to manage individual assets, optimising repair and maintenance costs, home selection and renter turnover. The sector benefits from strong tailwinds - demographic trends suggest that millennials will drive demand for single-family home rentals as they look to move out of their parents' homes or rented apartments and move to the suburbs. The high cost of purchasing and financing a home combined with an increasing propensity to rent are likely to benefit the sector for years to come.

Medium-term earnings growth prospects for global real estate stocks remain relatively robust due to the lag effect of long-term leases and solid operating fundamentals. Listed real estate currently trades at an estimated forward FAD (Funds Available for Distribution) yield of 4.71%. Current pricing, considering current global real estate market fundamentals, appears about fairly valued on a long-term risk-adjusted basis.

INVESTMENT OBJECTIVE

This specialist fund offers real estate focus, with global diversification. The real estate focus is through real estate securities with a specific bias towards stocks classified as investors, as opposed to developers. The investor classification is defined as those stocks that have 70% or more of their income derived from rent. The guiding principle is the ownership of real estate assets, primarily to earn rental related income streams which provide a stable underpin to long term returns. Global diversification is across geographic regions, currencies, countries and real estate types. The intention is to provide an attractive risk-adjusted return to form part of a multi asset class portfolio.

The fund benchmark is the FTSE EPRA/NAREIT Developed Rental Index, which comprises of stocks in the following regions: United States, Canada, UK, Europe, Japan, Hong Kong, Singapore, Australia and New Zealand.

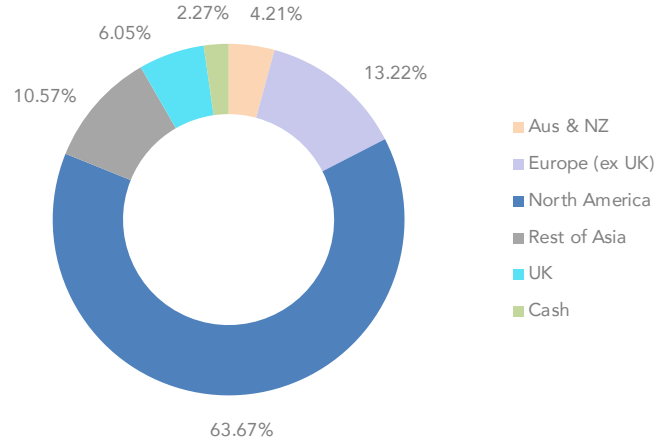

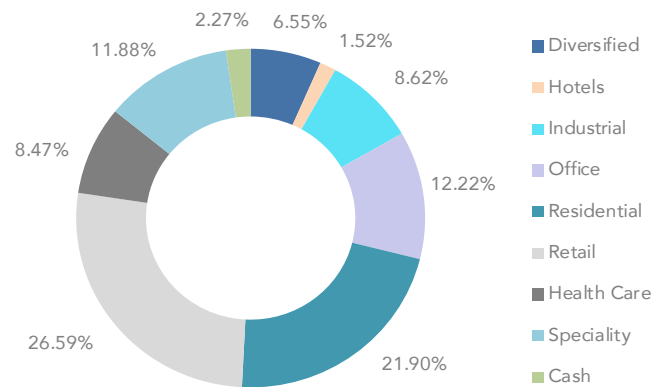

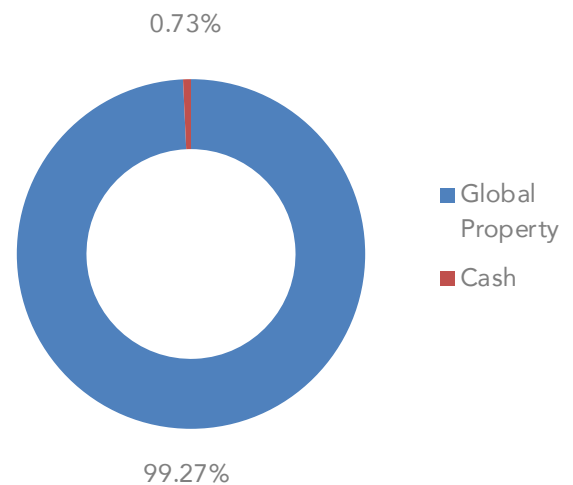
Underlying Funds Geographic Allocation as at 31 December 2017
