MONTHLY COMMENTARY

The SA Listed Property Index (SAPY) and the All Property Index (ALPI) recorded total returns of -1.06% and -1.25% respectively for the month of December, with the historic yield of the SAPY ending the month at 9.41%. The yield-to-maturity (YTM) on the Long-Term South African government bond (RLRS) remained flat ending the month at 9.22% (9.22% - 30 November 2018).

SA Equites recorded the highest total return (4.25%) for the month of December, followed by SA Bonds (0.64%), SA Cash (0.60%) and SA Property (-1.06%). Quarter-to-date performance, SA Bonds outperformed other asset classes recording a total return of (2.80%) with SA Listed property recording total returns of (-3.99%) over the same period. SA Listed Property (SAPY) continues to underperform other asset classes on a rolling 12-month period, with SA Bonds outperforming with returns of 7.74%, followed by SA Cash (7.29%), SA Equities (-8.53%) and SA Property (-25.26%).

It has been a tough year for equity markets and in particular listed property. Going into 2018 the property sector delivered a healthy return of 4.2% in December 2017 buoyed by the positive sentiment following Cyril Ramaphosa's victory in the ANC elections. The elation was short lived as in January 2018 the sector recorded a total return of -9.91% for the month, one of the worst months on record. Domestic property fundamentals have remained weak as lacklustre economic growth and high unemployment continued to place pressure on domestic demand and supply conditions. Listed property is still expected to face tough conditions over the short to medium term as oversupply across subsectors will remain stubbornly high without meaningful GDP growth to provide the impetus for demand. Looking ahead, 2019 is expected to be an interesting year with national elections in May 2019 and along with that the uncertainty regarding the outcome of the ongoing FSCA investigations into the Resilient group of Companies. On average, SA centric companies are trading at forward yields above the long-term South African Government Bond proxy (RLRS). Similarly, dual listed offshore companies are trading at attractive forward yields relative to their respective long-term government bond yields. We expect the sector to achieve inflationary growth in distribution per share over the medium term.

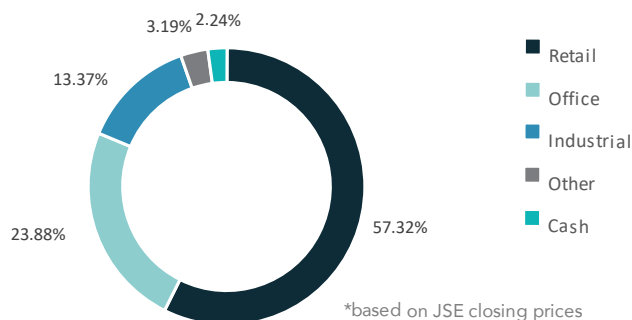

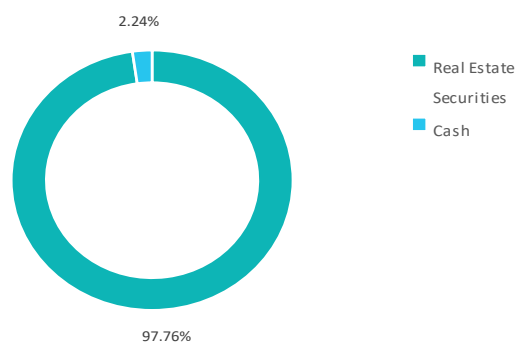
FUNDS SECTORAL ALLOCATIONS AS AT 31 DECEMBER 2018
