Investors should be prepared for a minimum investment term of at least three years.

MONTHLY COMMENTARY

Our fund benchmark, the FTSE EPRA/NAREIT Developed Net Rental Index, recorded a net total USD return of 0.71% in July. The best performing listed real estate market was Japan, which recorded a total USD return of 2.81% for the month. Hong Kong recorded the lowest total USD return of -6.74%.

As dedicated real estate specialists, Catalyst Fund Managers are strong advocates of listed real estate as a long-term investment. As fund managers, we consider the total return profile for investors, comprising of capital appreciation as well as an income return from regular dividends, which tend to grow closely with inflation over time. We spend a tremendous amount of time and energy identifying which real estate assets should experience superior rental income growth and capital appreciation over time. In order to do this, the team must construct a view of supply and demand fundamentals, assessing how prone this is to change in the future.

When attempting to quantify and forecast demand growth, common demand factors considered by participants in the real estate industry are per-capita income, population, employment, and the growth in these factors. Of these, the most important is per-capita income growth as it directly relates to the customer's ability to pay higher rents across a variety of real estate types. Additionally, the other factors tend to move in lockstep with supply growth, as the need for liveable and workable space is addressed by new supply. However, through gentrification of neighbourhoods, lower income jobs are displaced by higher paying, more productive jobs often in growth industries. This does not necessarily require, or happen in conjunction with, an immediate new supply of space.

In times where there is strong demand from users of space, and limited availability of the type of space they desire, landlords have leverage over their tenants and can increase their rents. As higher rents become achievable, increasing development profits render development more feasible. Without barriers to new supply, strong demand will drive rents, which in turn will elicit a supply response. New space provides tenants with greater optionality as to where they locate, tilting bargaining power in their favour as the landlord attempts to retain them. This hinders the ability to charge higher rents, or potentially results in concessions, lower rents and ultimately vacancies. As such, incremental demand can often be offset by marginal supply. Therefore, it is imperative to identify barriers to new supply. These can generally be classified as physical, regulatory and technological barriers.

Overall, real estate fundamentals remain healthy, mainly due to manageable supply levels relative to demand. The estimated forward FAD (Funds Available for Distribution) yield for the sector is 4.69%, and medium-term growth prospects are decent. Listed real estate has performed well this year and, on the whole, appears to be fairly priced given our USD real return requirement of 5.00% and current global bond yields. Within the real estate universe, more attractively priced opportunities exist in specific real estate sectors and stocks.

INVESTMENT OBJECTIVE

This specialist fund offers real estate focus, with global diversification. The real estate focus is through real estate securities with a specific bias towards stocks classified as investors, as opposed to developers. The investor classification is defined as those stocks that have 70% or more of their income derived from rent. The guiding principle is the ownership of real estate assets, primarily to earn rental related income streams which provide a stable underpin to long term returns. Global diversification is across geographic regions, currencies, countries and real estate types. The intention is to provide an attractive risk-adjusted return to form part of a multi asset class portfolio. The fund benchmark is the FTSE EPRA/NAREIT Developed Rental Index, which comprises of stocks in the following regions: United States, Canada, UK, Europe, Japan, Hong Kong, Singapore, Australia and New Zealand.

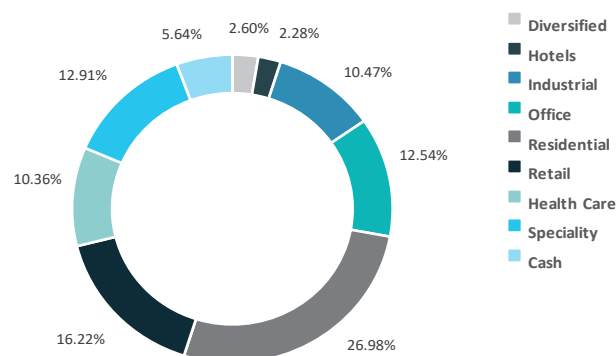

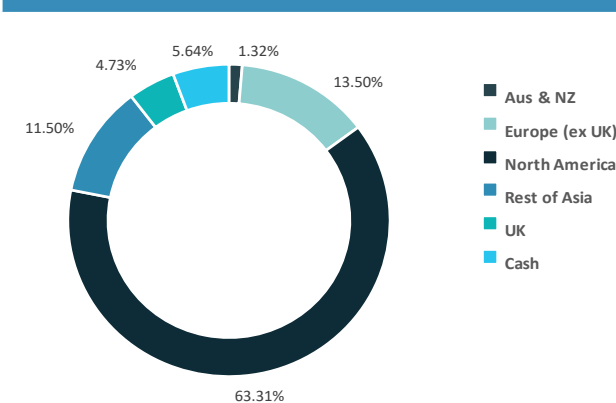

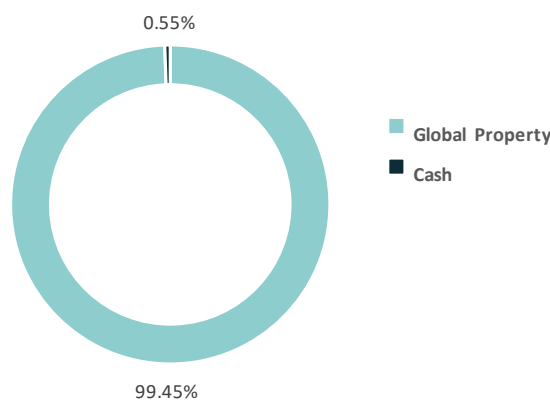
UNDERLYING FUNDS SECTORAL ALLOCATION AS AT 31 JULY 2019
