### MONTHLY COMMENTARY

The SA Listed Property Index (SAPY) and the All Property Index (ALPI) recorded total returns of -3.06% and -3.30% respectively for the month ended January 2020, with the historic yield of the SAPY ending the month at 10.26%. The yield-to-maturity (YTM) on the Long-Term South African government bond (RLRS) re-rated by 4bps in the month of January to end the month at 8.92% (8.96% - 31 December 2019). On a 12-month basis, SA Bonds were the outperformers with returns of (8.48%), followed by SA Cash (7.27% and SA Equities (7.14%). On a 12-month basis SA property continues to underperform the other asset classes.

Trading updates provided by listed retailers in the month of January suggest that difficult trading conditions have continued unabated. Low economic growth, high unemployment, load shedding and higher utility prices have impacted consumer confidence resulting in constrained spending in South Africa. Retail supply has begun to slow as funding for new retail schemes become increasingly difficult to secure and retailers become more selective in their store expansion.

Income yields have adjusted upwards in order to compensate investors for the risks in the sector and downward revision to growth forecasts. Whilst this is the case, we expect companies that have focused management teams that allocate capital based on long-term sustainable returns to outperform their peers. The sector is currently trading at a forward yield of 10%, with growth in distributions forecasted to be below inflation in the short to medium term. The muted growth and weak property fundamentals will weigh on a recovery in the sector in the short term. We anticipate total returns in the short term to be driven by the income component rather than capital growth.

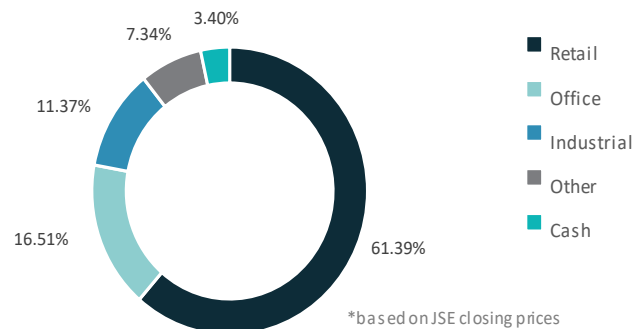

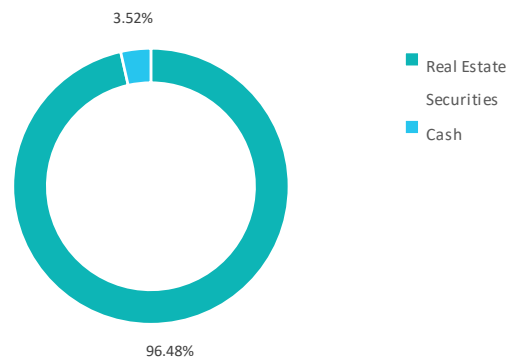
